General provisions

We attach particular importance to protecting the privacy of our customers, business partners and employees. We ensure that the processing of personal data is carried out in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter: RODO), the Act on the protection of personal data and special regulations.

We implement appropriate technical and organizational measures to ensure a level of security corresponding to the possible risk of violation of the rights or freedoms of natural persons. We develop policies and procedures, organize training courses to increase the knowledge and competence of our employees in this area.

When visiting websites managed by the Company or using services provided by electronic means, you have control over the personal data provided to us. We limit the collection and processing of information about users to the minimum necessary.

What do we use your personal data for?

The personal data we collect from you is used for:

- the performance of the contract;
- the performance of a binding legal obligation in the scope of tax law, accounting law, social security law, etc;
- ensuring the safety of persons and property on the premises of the Company by, among other things, recording data in the event of entering the premises of the Company as well as recording the image by the monitoring applied by the Company;
- contacting in order to present information about the current offer of the Company;
- sending marketing information on the basis of your consent.

If your personal data is processed on the basis of your consent, we inform you that it may be withdrawn at any time, including by sending an e-mail to the address: rodo@rolfroz.pl.

How and on what basis do we process your data?

We ensure that your data is:

- processed lawfully, reliably and transparently;
- collected for specific and legitimate purposes;
- adequate, relevant and limited to what is necessary;
- accurate and, where necessary, kept up to date;
- kept for no longer than necessary;
- processed in a way that ensures adequate security.

How long do we process your personal data?

The period of time for which we may process personal data depends on the legal basis, which is a legal prerequisite for the processing of personal data by the Company. In current policies, we specify that we may never process personal data for more than a period longer than the period specified in the above mentioned legal bases. When the Company processes personal data on the basis of:

- consent - the processing period lasts until the withdrawal of such consent by the user;
- legitimate interest of the data controller - the processing period lasts until the moment of determining the above mentioned interest;
- applicable laws - the period of data processing for the purpose of such processing is determined by such provisions;
- specific legal or contractual requirements - the period of data storage in the case of records and other documentary evidence prepared during the performance of the contract shall last for a maximum of 20 years.

What rights are you entitled to?

We take appropriate measures to provide, in a transparent, understandable and easily accessible form, give all relevant information and communicate with you regarding the processing of personal data in order to exercise your right to:

- access your data and receive a copy of it;
- correct your data;
- deletion of data, the so-called right to forget;
- limitation of data processing;
- lodge a complaint with the supervisory authority.

Subcontractors / processing entities / receivers

If we cooperate with entities that process personal data on our behalf, we use only those entities that provide sufficient guarantees of implementation of appropriate technical and organizational measures to ensure that the processing meets the requirements of RODO and protects the rights of data subjects. We examine these entities in detail and conclude the appropriate data-processing delegation agreements.

Authorizations

We assure you that anyone acting under our authority and having access to your personal data will process them only on our instructions, unless otherwise required by EU or national law.

Data Protection Supervisor

No Data Protection Inspector has been appointed in the Company.
